Agenda Items

1. IP Policy and Minute Taker
 - a. Policy accepted with Mike taking the minutes
2. Review minutes from PWG F2F

 - b. Accepted with fix for the title
3. Review updated charter

 - b. Discussion of updated title of mapping document: make it clear that the mapping is only between PWG Job Ticket and other formats, and not an N-to-N mapping between them all.
 - What about PWG Print Service Capabilities in the title?
 - New title: "Mapping of MSPS, PPD, and JDF to/from PWG Print Job Ticket and Print Service"?
 - c. Update description of document to match title (not just capabilities, but print service elements for capabilities and description)
 - d. OBJ numbering: fix it (first one is currently OBJ-A)
 - e. OBJ-A: Move links to references section at end
 - f. MSPS vs PSF: Reference MSPS, not PSF (the framework is part of MSPS)
 - Verify MSPS link as durable.
 - g. Action: Mike to send list of references for PPD to cloud list
 - h. Remove comment about MSPS
 - Delay approval of charter update until we hear back from MS legal
 - Continue work on mapping document for PPD/JDF in the meantime
 - i. Next status of document is STABLE
 - j. Issue: No prototyping requirement for Best Practices document
 - How to ensure the mapping is correct?
 - Can we get a vendor to prototype PWG to something?
 - k. Q: Where to put "top 10" list of print job ticket elements?
 - Print Job Ticket document will include a list of commonly-used elements
 - l. Issue: Print Job Ticket spec needs to be a normative reference, so that needs to complete in the same timeframe.
 - PJT is #1 document in SM WG, still have some additional capabilities and commonly-used elements text to add.
 - No issues seen in getting the document through
 - m. Update milestones for prototype and last calls of IPP/SOAP printing bindings to be Q4 2012 and Q1 2013, respectively.
 - Also re-add interop dates with +1 year
 - n. Add references section
 - o. Action: Ira to post update for charter per the minutes

 - b. Would like having the Print Job Ticket, Capabilities, and Description elements in separate tables.
 - Also the reverse mapping tables?
 - Subsections for each SM grouping
 - c. Since PPD is not a job ticket format, need some discussion on how values are represented; highlight CUPS and Google usage
 - d. Format of mapping chapters:
 - Overview
 - Usage
 - Print Job Ticket
 - Print Service Capabilities
 - Print Service Description
 - e. NumCopies and CustomPageSize: add section reference to usage info
 - f. PageStackOrder: Not PageOrderDelivery since it is a output bin property - output tray property?
 - PageDeliveryOrientation, needs some discussion on OutputBin to OutputTray properties?
 - g. Section 1.1: Break out into separate sections for defaults, talk about unknown values
 - h. Collate mapping is a mess: MultipleDocumentHandling is the best match, JobCollationType and SheetCollate do different, more complicated things (defined originally in RFC 3381)
 - i. Section 1.1.3: SM uses keyword mapping of IPP enum values
 - j. Section 1.1.4: Add example to show mapping
 - k. Section 1.1.6:
 - Add discussion of imageable area to margins: bounding box to distance from edge
 - Add reference to appendix in PPD spec for standard PPD option keywords
 - Add Media as well as MediaCol
 - l. Section 1.1.7:
 - Use TitleCase versions of MediaSource
 - Add missing manual feed input slot
 - m. Section 1.1.10:
 - Use TitleCase versions of MediaType
 - n. Throughout: "The Adobe-defined" or "The CUPS-defined" instead of "The supported option keyword...", and "The most common" when we are using a subset.
 - o. Section 1.1.14:
 - Semantics of PageDelivery allow printer to reorder pages in order to render them to match intent.
 - Clarify that client needs to query supported values to determine which of the SameOrder or ReverseOrder values to use.
 - p. Section 1.1.15: Add examples
 - q. PwgRasterDocumentBackSide should be in PrintServiceStatus
 - This means that we are doing a sparse mapping to PrintService as a whole
 - Action: Pete to add PwgRaster elements to model from PWG Raster spec
 - r. Stopped at section 1.2.3
