3. Went through the PWG Intellectual Property policy.
4. Reviewed the outcomes from the latest two HCD TC Meeting held on Apr 25th and May 8th, 2017. The meeting slides provide a summary of the results from the two meetings.

There was general agreement with the recommendations as to what changes should go into the planned Version 1.1 “minor” update to the HCD Protection Profile (PP) that is planned for November 2018, and what changes should go into the next major update to the HCD PP. Those present at the meeting supported the consensus of the HCD TC that the TC’s next step should be to get the Common Criteria Development Board to approve the formation of a HCD international TC (iTTC) from the HCD TC so that the next major update to the HCD PP would be an HCD collaborative PP (cPP).

The following points were also made as part of the discussion:

- Bill Wagner asked a good question about process for the HCD PP Version 1.1 update and what will go into that update. In general, we only want minor changes (e.g., no new Security Functional Requirements (SFRs)) in this update, although the proposed change to make an optional SFR a mandatory SFR may not be considered a “minor” change in this context. We also really need a more formalized process for integrating the NIAP Technical Decisions into updates to the PP.
- Bill Wagner's question about scope/impact versus dot- or major-release was a good one. In the case of FAU_STG I think it is a correction of requirements, not a requirement that vendors aren't already meeting, but it does add some documentation and an assurance activity, so it's still work considering this sort of thing. It's something we can keep in mind during the HCD PP v1.1 update but something we might want to codify in either the iTC Terms of Reference or a Printer Interpretation Team (PIT) policy.
- The issue of TLS1.0, TLS1.1, and SHA1 may be worth looking at and perhaps leveraging/referring to the RFC about deprecating those three items. One of the proposals that was agreed should go into Version 1.1 is to delete the requirement to support TLS 1.0. Some thought that should be expanded to also delete the requirement to support TLS 1.1; there was no consensus on that request, however.
- The IETF "Using TLS in Applications (uta)" working group has an interesting wiki, here's the document page: <https://datatracker.ietf.org/wg/uta/documents/>. We might be able to use some of this, if nothing else, to argue against the nastier parts of a NIAP TLS package.

Wrap Up

- We will schedule a future IDS Conference Call sometime in June/July 2018 to review the draft HCD PP Version 1.1.
- We will also have at least a 1-hour IDS session at the August 2018 PWG Virtual F2F to review the status of HCD PP Version 1.1.
