Status/Action Item Discussion 2



- Include MFD Printer MIB Alerts extensions in IPP JPS3
 - > + Relatively small amount of information that does not justify a separate document.
 - > + Alert messages used in IPP as well as Printer MIB
 - Printer MIB is independent of IPP, and has users not involved with IPP. Information will be buried.
 - Schedule for JPS3 is not determined. May amount to repigeonholing the MFD Alerts effort.
- Printer MIB integration document
 - Identifies existing MIBS necessary/desirable for Printer management
 - Defines compliance level??
 - Limited to MIBS??

- (2) Technical delete all 10 PowerGeneral.MaxXxxRecords elements DONE
- (3) Technical reduce PowerMeter from RECOMMENDED to OPTIONAL DONE
- (4) Technical reduce PowerSupport from RECOMMENDED to OPTIONAL DONE
- (5) Technical reduce PowerTransition from RECOMMENDED to OPTIONAL DONE
- (6) Minor editorial fixes to PWG Power Model and PWG Power MIB - DONE

Suggested General Guidelines



- Submission consists of basic article, set of references, and 10-15 survey questions
- Basic article should:
 - Identify the issues and associated problems
 - Reference existing solutions and applicable standards
 - Discuss what PWG is doing, or planning to do to address the issues
- Basic article length should be 1000-1500 words
- Pictures are good, if they illustrate the point
- Survey questions should provide feedback on:
 - Whether the issues reflect what MPS providers are seeing
 - Other related issues that are being observed
 - Reaction to proposed solutions
 - Questions we have on field experiences and observations

 - Both groups of issues involve security (IDS) and Management (WIMS) aspects

 - Solutions and Standards that Address (Web Services, 'secure' SNMP variations, communication initiation by device
 - PWG activity CIM effort

January MPSA Article - Approach



Logging

- > For Security Audit Trail
 - Issues from IEEE Std. 2600
- Accounting Billing and Charge Assignment
 - Issues develop from Counter Spec
- > Rational for using common approach
 - Interrelation (e.g., some accounting info may require security; access rights different)
 - Solutions and Standards that Address (Standard Logging formats)
 - PWG activity logging work, what else?
